1. Generic

Bidders are bound to accept the orders accordingly.

2. Generic

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

- 1. Original license Certificate should be provided .

- 3. Bidders should carefully study the documents of this enquiry. All terms and conditions set out there in the enquiry shall be binding on the bidders unless conflicting with any terms and conditions expressly stated by HOCL while accepting any bid, in the event of such acceptance.
- 4. Bids shall be valid for a minimum of 60 days from the due date for receipt and opening of the bids.
- 5. Specification of the Product: Specifications offered product shall be uploaded along with technical bid.
- 6. Payment terms shall be: GeM standard Payment terms.
