- Bidders should carefully study the documents of this enquiry. All terms and conditions set
 out there in the enquiry shall be binding on the bidders unless conflicting with any terms
 and conditions expressly stated by HOCL while accepting any bid, in the event of such
 acceptance.
- 3. Bids shall be valid for a minimum of 60 days from the due date for receipt and opening of the bids.
- 4. Specification of the Product: Specifications offered product shall be uploaded along with technical bid.
- 5. Payment terms shall be: GeM standard Payment terms.
- 6. Tenderer should agree for inspection of material at their site, if desired by HOCL. The inspection may be carried out by the representative of HOCL or by a third party or jointly.
- 7. The Tenderer must specify their GSTIN No& HSN code of material offered in the BID
