## NOTES

## 1.SCOPE OF WORK:-

1. The transformer oil will be made available as per our convenience for filtration.
2. The oil to be filtered by Hot Stream Process. Minimum of three circulation of oil is to be conducted.
3. The BDV test of oil before and after filtration should be carried out and certificate to be submitted. The value should withstand 50KV one minute in 2.5 mm gap.
4. The work should be carried out as required by us during the period of the contract (two Years).
5. The repairing works of transformers/breakers like oil leak arresting, gasket replacing etc. to be attended by the party. The payment will be paid extra for the repairing works.

For the filtration of oil in various equipments at our plant it may be required to filter the oil when the equipment is in service/idle. We shall provide 3phase/single phase supply for filtering and testing purpose. Details of filtering unit are to be furnished.

YOUR RATE SHOULD INCLUDE TRANSPORTATION CHARGES FOR THE FILTERING UNIT, CHARGES FOR SUPERVISOR ETC.

Minimum three circulations of oil are to be conducted before BDV test. Value should not be less than 50 KV for one minute on 2.5 mm gap. Two samples of each of the oil should be tested before and after filtering and reports to be furnished. Necessary arrangements should be made to protect from rain while filtering.
