### NOTE:-

The refilled Toner & cartridge shall be supplied latest by the next working day. The supply of urgent nature shall have to be made on the same day.

### SPECIAL TERMS AND CONDITIONS:

- 1. Empty toner cartridges shall be provided by the MSS Dept, for refilling. Supply Order will be placed on requirement basis .The supply cartridges shall be collected personally by the contractor or his nominated persons from the HOCL prem ise.
- 2. The Toner/cartridge shall be in compliance with the specifications mentioned in Annexure 2 of the tender and shall be of the best quality and high standards.
- 3. Only original parts should be used for replacement of damaged or defective parts. The replacement component shall be of suitable and should in no way hamper the performance of the equipment.
- 4. Any fault with refilled toners/cartridges that arises within two weeks of installing the cartridge in printer, the same will have to be replaced / rectified by the party free of cost. HOCL will maintain record of installing the refilled toner /cartridge i n each printer.
- 5. No claim for compensation or loss due to fluctuations in prices or any other reasons/ causes on any circumstances will be entertained during the period of contract.
- 6. The rates quoted for refilling of toner cartridges shall be inclusive of replacement of all key parts, refilling of toner powder, taxes, etc. complete in all respects as per scope of work. Nothing extra shall be payable on any account
