#### 1.SCOPE OF SUPPLY:-

- 1. The contractor should carry out the work as per the schedule of works.
- 2. All tools, tackles, required for the work shall be brought by the contractor at his cost.
- 3. HOC will provide water and electricity at one point.
- 4. Steel scaffolding as per the standards wherever required has to be arranged by the Contractor at his cost.
- 5. The labourers engaged in the work shall use necessary personal protective equipment.
- 6. All materials that go with the work shall be approved by the Engineer-in-Charge prior to procurement/ use.
- 7. The contractor shall allow using only approved make/quality paints. The approved makes are Asian Paints, British Paints, Berger Paints, Shalimar Paints and Dulux Paints.
- 8. The contractor shall ensure proper cleaning of surfaces before painting. The entire deteriorated paint surface shall be removed before application of paint, no extra payment shall be made for this.
- 9. During the execution of work, care shall be taken to protect all the instruments, furniture's etc. The working of the weigh bridge shall not be disturbed during the execution of the work.
- 10. Cracks shall be properly filled with plaster or putty prior to painting to walls.
- 11. Dismantling brick masonry work for providing windows as per the direction of engineer in charge.
- 12. The contractor shall make necessary arrangements for dismantling the existing steel windows for providing new sliding windows. The usable scrap materials shall be stacked with in the company premises as per the direction of engineer in charge.
- 13. The work shall be carried out as per the directions and entire satisfaction of the Engineer in Charge.
- 14. Deployment of supervisor: The contractor shall deploy a qualified Supervisor throughout the contract period.
- 15. Necessary safety appliances like safety shoes, helmets, safety belts etc. shall be brought by the employees of the contractor during the work
- 16. If there is any variation in the quantity during execution of work, that shall be informed to the engineer in charge.
- 17. After completion of the work the area should be properly cleaned
- 18. Priority area as instructed by the Engineer-in-charge should be completed as per the requirement and the total work has to be completed within the stipulated time limit.

#### 20. Specifications and mode of measurements:-

All items of work shall have the best workmanship and be executed to the entire satisfaction of the Engineer-in -charge. Unless otherwise specified, the specifications and mode of measurements for various items of work shall confirm to the standard detailed specifications and mode of measurements for works.

The contractor shall account for all departmental materials issued to him and submit material reconciliation statement and will be dealt with in accordance with clauses 3 of standard special conditions of contract. Penal recovery at double the issue rate shall be effects in case of shortages or other irregularities of departmental materials. The theoretical consumption for cement consumption for various items shall be worked out on the basis of CPWD standard rate of consumption.
