## NOTES

1.SCOPE OF WORK:-

1. The contractor should carry out the work as per the schedule of works

2. All tools, tackles, required for the work shall be brought by the contractor at his cost.

3. HOC will provide water and electricity at one point

4. Steel scaffolding wherever required has to be arranged by the Contractor at his cost.

5. The labourers engaged in the work shall use necessary personal protective equipment

6. All materials that go with the work shall be approved by the Engineer-in-Charge prior to procurement/ use.

7. The contractor shall allowto use only approved make/quality paints. The approved makes are Asian Paints, British Paints, Berger Paints, Shalimar Paints and Dulux Paints.

8. European closet shall be of CERA/ PARRYWARE/ HINDWARE make and the cost includes cost of all items, such as closets, 10 Litre capacity flush tank, P/S trap, making connection to the existing line etc. complete.

9. The work includes connecting the outlet line to the existing soil/sewer line including chipping and removing the floors/walls and finishing the same in required lines and levels.

10. PVC pipes and specials used shall be 10kg/cm2 pressure pipes of approved make like SUPREME/ HYCOUNT/ KELACHANDRA or equivalent quality.

11. C.P fittings such as taps, stop cock, health faucet etc. shall be of ZOLOTO/ CERA/ PYARRYWARE or equivalent approved make

12. Partition walls are to be constructed inside the existing toilets to separate the water closet room Reinforcements shall be provided where ever required during partition wall construction as per the direction of engineer in charge

13. Cement concrete blocks shall be of standard make and conforming to IS 2185.

14. Ceramic urinal partitions shall be of CERA or equivalent make. Urinal partition shall be fixed in to the walls without damaging existing wall tile; any damages to wall tiles shall be rectified by contractor at his own cost.

15. Opening for ventilators and exhaust fan shall be provided by dismantling brick masonry work where ever required

16. 110 mm dia pvc pipe shall be provided from new European closet and it should be properly fixed on outer wall by cutting the wall and connected to the existing soil line/existing chamber. Including making good the wall.

17. The sewer/waste line shall be properly laid without any leakage

18. New aluminum ventilators shall be powder coated aluminium sections for outerframe, shutter frame with 4 mm thick plane glass openable type , the sections shall be Jindal/Malabar or equivalent make

19. Floor traps are provided where ever required by chipping the floors/ walls in neat lines and levels includes connecting with the existing line

20. PVC doors shall be sintex or equivalent make existing wooden doors are to be dismantled and the surface shall be finished neatly.

21. If there is any variation in the quantity during execution of work shall be informed to the engineer in charge

22. After completion of the work, the entire toilet area should be properly cleaned.

23. Before quoting the work, the contractor should visit the site and understood the scope of work. Any clarification in this regard should be got cleared from the Engineer-in-charge

Cement and tor steel required for the work will be issued departmentally from HOCL Stores on free issue basis. The contractor shall make his own arrangements for collecting and transporting materials to site and return the surplus serviceable /scrap materials to HOCL stores for which no extra payment will be made. The contractor shall account for all departmental materials issued to him and submit material reconciliation statement and will be dealt with in accordance with clauses 3 of standard special conditions of contract. Penal recovery at double the issue rate shall be effects in case of shortages or other irregularities of departmental materials. The theoretical consumption for cement consumption for various items shall be worked out on the basis of CPWD standard rate of consumption
