- 11. The quantity shown can vary ie. Increase or decrease depending upon the situation. However, the rate and other terms and conditions shall be same throughout the pendency of the contract for which the contractor shall be ready.
- 12. Appropriate insurance shall be arranged by the contractor for the coverage of the liability to the people employed by them, arising out of any accident occurring during the execution of the work.



- 13. HOCL will not entertain any claims or responsible whatsoever in the event of any accident/incident.
- 14. The Contractor shall follow all clause in Annexure –A, B & C like ESI, Safety Regulations and General Conditions of Contract, Workmen Compensation, Personal Protective Equipments (PPE), Labour Laws, PF, Guidelines to contractors / suppliers for environmental protection & Confined Space Entry
- 15. Contractor shall get prior permission from the Engineer-in-Charge for bringing the material to HOC.
- 16. Contractor shall ensure that a standby person is kept outside the man-way nozzle when the work is inside a confined space.
