PRE-QUALIFICATION CRITERIA (TO BE INCLUDED IN THE TECHNICAL BID)

The Tenderers shall submit the following in the Technical bid (Un-priced Bid) without which the tender will be rejected.

- 1. Complete set of Tender documents marked "(ORIGINAL)" duly filled in and signed by the Tenderer as prescribed in different clauses of the Tender document.
- 2. Details of current commitments with copies of Work Orders to be submitted along with Technical Bid.
- 3. Experience of having successfully completed similar works during the last 3 years ending last day of month previous to the one in which applications are invited.
- 4. Those who are having chemical handling experience especially in Phenol/Cumene/Acetone/Hydrogen Peroxide and they have to attach their experience certificate.
- 5. GCC duly filled in the relevant portions, signed and stamped all the pages by the tenderer (The tenderers have to download the GCC (General Conditions of Contract) from our web site <u>www.hoclkochi.com</u> and the same has to be returned along with the technical bid duly signed and stamped in all pages.
- 6. The bidder should have adequate number of tools/tackles in sound condition for the execution of the work within the stipulated time.
- 7. Exceptions and deviations, if any, with reference to the Clause No. and page No. of Tender shall be submitted as a separate statement (Deviation Statement)
- 8. In the case of MSME, necessary certificate (self-attested) shall be submitted.
- 9. Any other technical information the Tenderer likes to furnish.

EARNEST MONEY DEPOSIT

SECURITY DEPOSIT

- Total security deposit shall be 5% of total contract value.
- Security deposit shall be recovered through deductions at the rate of 5% (Five percent) of the value of each running account bill till the total security deposit amount is collected, after which no further deductions shall be made on this account. TIME OF COMPLETION

ONE year from the date of instruction to start the work.

PERIOD OF CONTRACT

Period of contract shall be **ONE year** from the date of instruction to start the work.

PAYMENT TERMS

Payment will be made on a monthly basis, one week after the submission of valid bill/final bill, shall be certified by the Engineer-in-Charge after deducting the Security Deposit and Liquidated Damage as applicable.

<u>RATE</u>

Rates quoted shall be inclusive of all taxes, duties, octroi and other levies etc. GST, in case applicable shall be paid extra. The bidder should have GST registration with Central Excise Department.

PERFORMANCE SECURITY (PERFORMANCE BANK GUARANTEE)

The performance security shall be 10% of the total value of the contract. It shall be furnished within 21 days after notification of award of work and shall be released after the defect liability period.

The above maybe furnished in the form of account payee Demand Draft/Bank Guarantee issued from any commercial bank in India/on online payment in an acceptable form.

VALIDITY OF OFFER

The offer shall be valid for a period of 90 days from the date of submission for placement of order.

SCOPE OF WORK

- 1. Following are the list of works to be carried out in Phenol and H_2O_2 plants.
 - a) Whenever there is leakage, the chemicals are to be collected in drums or in cans. The collected chemicals in drums are to be transferred to respective tanks or sumps as instructed by Engineer in charge.
 - b) Cleaning and dechoking of all the plant open drains to ETP and decoking of process lines.
 - c) Removal of vegetation over the process vessels and equipments.

All the above works are to be carried out as per the instruction of Engineer in Charge.

The contractor should carry out the above-mentioned jobs as per the schedule of work.

- Some of the above works in the plant may be considered as an emergency activity. Whenever there
 is emergency, the contractor has to put all efforts to complete the work in time. Also, the contractor
 has to deploy people round the clock if situation warrants as per the instruction of Engineer in
 charge.
- 3. Safety Helmets, Safety shoes, safety goggles, safety belts and other PPE etc. for the workmen and supervisor employed for the work are to be arranged by the contractor.
- 4. Either the contractor or his authorized supervisor shall be available at work site throughout the work. Contractor or any one of the contractors workman must be available from 8.00 A.M. to 4.00 P.M. on all working days.
- 5. Contractor shall get prior permission from the Engineer in charge for bringing any accessories for work to HOC and returning the material from HOC after completion of work.
- The Contractor should follow all clause in Annexures A, B & C like ESI, Safety Regulations and General Conditions of Contract, Workmen Compensation, Personal Protective Equipment (PPE), Labour Laws, PF, Guidelines to contractors / suppliers for environmental protection & Confined Space Entry.
- 7. As a measure to contain the spread of COVID-19, the following PPE are essentially provided to your workers:

1. Face Mask2. Face Shield3. Gloves

Also, all your workers are to be subjected to temperature screening at security, hand wash at the entrance, maintain physical distancing as far as possible.

- 8. Before quoting the work, the contractor may visit the site and understand the scope of work, if found necessary. Any clarification in this regard shall be cleared by the Engineer in Charge.
- 9. The Contractor shall strictly instruct his workers not to spit in the public places and area of work.
- 10. If the contractor or workman stays back for the continuation of the work after the normal 8 hours of work, the additional work hours will be compensated on pro-rata basis (Hourly)
