2. Routine motor test reports and Warranty for Minimum One year shall be submitted along with delivery.
3. Acceptable makes: Kirloskar / Crompton Greaves / Bharath Bijlee / Siemens / ABB / LHP / CEMP / NGEF
4. Delivery of Motor: Within 60 days from date of issue of Purchase Order / Contract Order.
5. The specification sheet should be signed and submitted along with the offer. If any deviations you should mention it clearly.
6. The bid shall contain as integral part of the same the following compliance statement: "We have read, understood and accepted the terms and conditions of purchase and related documents forming part of this enquiry and agree to supply the goods in compliance with the same."

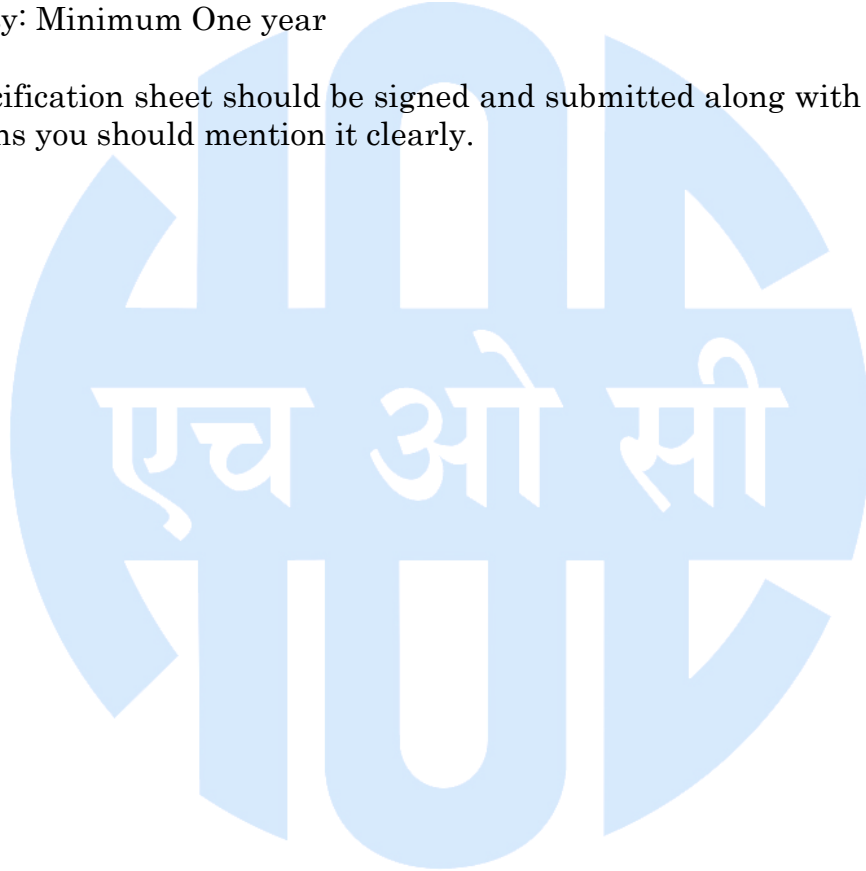

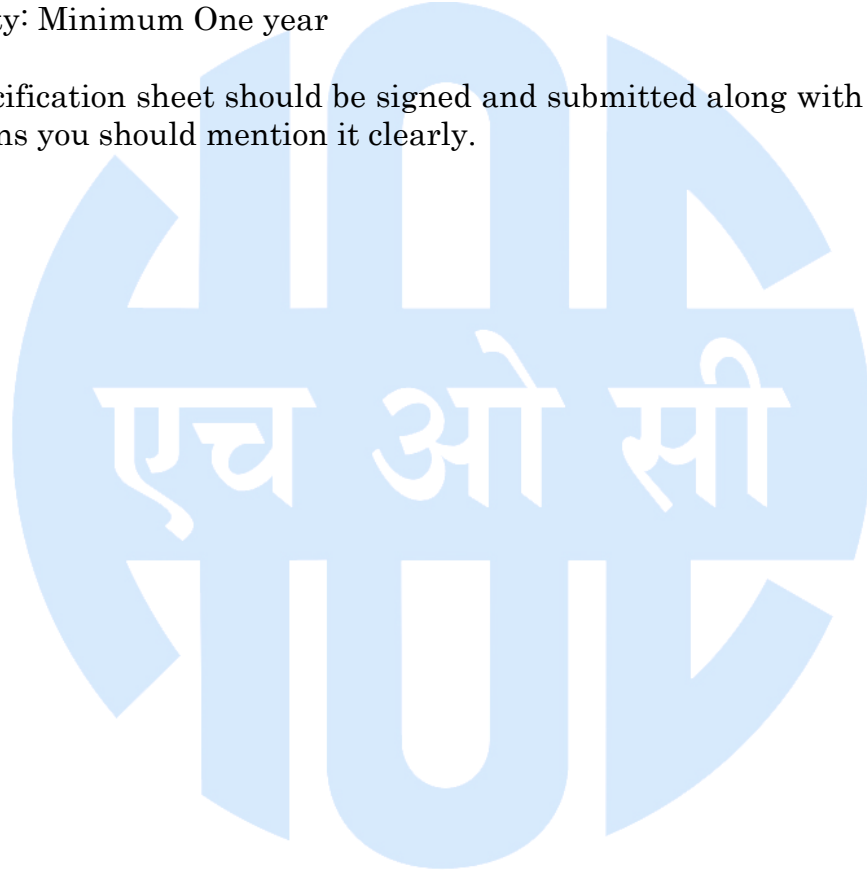
