In instant case the qualifying conditions in accordance of Hon'ble Supreme Court decision have been examined. Evidently the applicant fails to meet conditions laid down by Hon'ble Supreme Court. The member was given multiple opportunities through employer to rectify mistakes/errors including those made by employees/pensioners and to provide additional proof/evidence. The establishment failed to address the issues raised by this office.

On examination of the application, establishment reply and Area EO's report in this regard the following deficiencies were observed:

1. Applicant has failed to submit proof of remittance of higher wages on which PF contribution was remitted [exceeding the prevalent wage ceiling] for entire period as per circular Pension/12/33/EPF Amendment/96 Vol II/1946, dated: 04.06.2019;and
2. Establishment failed to submit Original documents in support of claims made in the application as per circular Pension/12/33/EPF Amendment/96 Vol II/1946, dated: 04.06.2019;and
3. Member/Employer does not comply to requirements of proof of joint option under concerned trust rule [equivalent to U/p 26(6) of EPF Scheme, 1952] as per Circular No. Pension/PoHW/23/Circular-26(6)/139610/1648 dated 14.06.2023 for the period from the day on which pay exceeded the wage ceiling or 16.11.95 whichever is later.
4. Establishment failed to provide documentary evidence of payment of administrative charges as applicable on higher wages.

In view of above, the applicant is not eligible in accordance of Para 44 (iii) and 44(iv) of Hon'ble Supreme Court Verdict.

Order

The application does not meet qualifying condition as laid down in Hon'ble Supreme Court judgement. The Application is thus rejected.
