Visit Note

In pursuance to the referred order team of officials visited at M/s Hindustan Organic Chemical Limited, 1003-1004, 10th floor ,NMS titanium premises, Co. op. Society Ltd. Plot No. 74 Sector 15, CBD belapur Navi Mumbai - 400614 for verification 492 PoHW category cases where members have continued in service post 01.09.2014. During the visit Shri. Jitender Malik Chief Manager (MSS/Fin/HR), represented the establishment. He produced following records regarding inspection for pension on higher wages for the employees continues service post 01.09.2014.

- 2. Payroll Slip of Employees(1995 onwards),

Physical records for corresponding foxpro data (data available in soft copy) to year from 1995 to 2001 is not traceable.

Observations on the basis of above submitted records:-

- 1. The Establishment was exempted for the period 1964 to June 2018. Further the exemption was surrendered in the month of June -2018. The establishment is complying the EPF & MP act 1952 as Un -Exempted from July 2018. The name of Trust "HOC Employees PF Trust"
- 2. A letter is submitted by establishment enclosing list of 47 employees whose Basic pay plus DA never crossed Statutory limit i.e. Rs. 15000/-. List is enclosed herewith for further necessary action
- 3. As per trust rule 8.01 (iv).

"The Amount of Member's compulsory contribution shall be 8% of his salary as defined in these rules."

- Whereas there is no restriction of statutory limit for contribution 1.
- EPFO contribution rate for period are as follows:-11.

- a. 01.04.1956 to 31.03.1971 6.25%
- b. 01.04.1971 to 31.07.1988 8%
- c. 01.08.1988 t o31.05.1990 8.33%
- d. 01.06.1990 to 08.04.1997 10%
- e. 09.04.1997 to 21.09.1997 10%

Establishment failed to produce minutes of meeting/ Trust rule change records for enhancement of contribution in line with EPFO.

- 4. Team scrutinized about 53 cases on the basis of above submitted records following are the observation:
 - a. Contribution rate not being uniform. Sample of same are as follows:

- b. There is a difference of around Rs. 1000 to Rs. 5000 in salary statement submitted in Pension on higher wages application & PF slip for the period from Jan 1997 to Sep -2001, Jan 2007 to Feb -2010 & Jan 2014 to Sep 2015. All the variation is above the statutory limit as defined by EPFO for time to time. (all differences are shown in 53 scrutinized cases enclosed).
- c. Supplementary payment is also given in some months on which the contribution rate given at the prescribed rate of 12% only. Supplementary payment has been seen maximum in the following month.

Aug -1996, may 1997, Nov 1998, April 1999, may 1999, May 2000, July -2000, Sep -2001, Nov -2001, Jan -2002, March -2002, Sep 2008, Oct 2008, Feb -

2010, Sep -2010, June -2011, Sep -2012, Dec -2012 & Feb-2014.But it is not mentioned that supplementary payment is made for which month.

d. During scrutiny of challans it is found that the inspection charges has been deducted at the prescribed rate of 0.18% only, but the total wages of all the employees on which inspection charges has been deducted is neither matching with the payroll schedule attached in the challan file nor with the salary register. The total number of employees has also not been mentioned in the challans. Total wages mentioned in challan is more than the wages mentioned in payroll schedule from 1% to 70% (1%, 1.33%, 4%, 10%, 62%, 70%) for example -Nov -2009, Oct -2010 and in few cases the wages mentioned in challan are less than payroll schedule for example Feb -2010, Sep -2010, Oct -2010, Dec -2010, Jan -2011.
